Planning is required to afford things needed tomorrow that require investing today's dollars proactively. It is very important to maintain today's standards without increasing tax burdens, but there are responsibilities in the process where small or short-term tax additions may be needed to fund the future. Funding resources are also possible for use in the right economic climate and for the right reasons if the need warrants and can possibly avoid needed tax increases.
