What are your views on state tax policy, being as specific as you can? (100 words or less)

Would prefer to eliminate sales taxes on food, and implement fourth income tax tier. We've made significant improvements in last few years, but have a ways to go to protect the middle class.

With record low unemployment rates, what would you do to grow and develop the state's workforce? (75 words or less)

Businesses are attracted to healthy communities with amenities that attract families - supporting public education, public parks, and increasing access to continuing education opportunities, at universities, community colleges, and labor apprenticeships.

I do not believe we have constitutionally funded k-12 education, and that there are additional funds that need to be directed to Special Education populations and at-risk populations.

What would your priorities be in any new statewide transportation plan? (50 words or less)

To fund infrastructure maintenance, so that we can catch up on the backlog of roadwork that has been neglected during the years of the Brownback tax experiment.

Do you support maintaining the current dedicated sales tax transfer to the State Highway Fund for the purpose of funding transportation infrastructure, or should transportation be

#### subject to the appropriations process where legislators determine funding levels entirely? (50 words or less)

Support the current fund. If legislators determine the funding level entirely, I fear that funding cuts would be tempting for those who prefer to eliminate taxes for the wealthy.

#### What types of economic development policies will you support to encourage job growth and business expansion in Kansas? (50 words or less)

Our neighboring states have child care tax credits, and we lack this. Providing this benefit would help increase the workforce and allow working families to more readily meet their bills.

I support creating legal pathways for immigrants, and to help meet the needs of employers facing shortages. However, immigration is within the jurisdiction of the federal government.

The state should maintain work comp statutes and other protections to ensure a safe work environment.

I believe the Department of Children and Families is in serious need of policy improvements and additional funding. I created the Foster Care Task Force to review and recommend policy updates, which are to be delivered this fall.

The DCF Taskforce, passing my Election Audit Act, passing the Minor's Credit Protection bill, and passing a bill to protect victims of domestic violence after a first attack (previously statute required to incidents for protection orders).
