Source Water Protection – Continue partnerships to reduce harmful algal blooms in the Kansas River watershed. The Kansas Water Office is the lead partner in the Regional Conservation Partnership Program (RCPP) for the Milford watershed.

Customer Service – Continue the emphasis on customer service. We have seen continuous improvement and higher ratings, as measured by quarterly surveys.

WaterOne is a unique public entity. It is a non-profit operated solely for the benefit of its customers. The district is run efficiently and is managed to its fiscal plans.
