10. As a candidate, what are your top three policy issues? (100 words or less)

1: Affordability: Gardner maintains one of the lowest mill rates in Kansas for a city of its size. Our city-owned utilities rates are very comparable to others. Our housing prices remain more affordable than many other Johnson County cities.

2: Safety: Insuring our public safety (police) have what they need to keep our community safe is (and always has been) very important to me.

3: Responsible development: Bringing commercial businesses to Gardner provides more options for our residents and also

helps to lower the tax burden for citizens.

I believe our citizens receive a great value for their tax dollars. Our roads are generally well-kept (main st/56hwy maintained by the State of Kansas being the current exception.) Our community scores high on Safe places to live. Our park and trail systems offer many amenities. And, owning our utilities allows affordable rates with exceptional service.
